LOON REPORT Kathy Garmes-Taylor Loon Ranger



Last year we were unsuccessful in having any loon chicks. The artificial nest was placed at the same location and the loons started nesting; then Cristobal hit! It blew the nest across the bay and it ended up lodged at Harris Point. The loons never got back on the nest. It was sad to see that there were 2 eggs on the nest when we brought the nest to shore in July.

We tried to prepare for another windy spring by putting out a permanent, VERY HEAVY anchor in the location where we place the nest. You might have noticed a buoy; it marks the location of the anchor. The nest will be placed in the same location once the ice is out and the loons are spotted. Getting the nest out as soon as we can is desirable, but we do need a boat to tow the nest. TREASURER'S REPORT Kathy Garmes Taylor, Treasurer

The audit of the books for the year ending December 31, 2020 was completed in January, 2021.

- (a) Total income was \$4,423.25.(b) Total expenses were \$3,974.08.

(c) The net result was a surplus of \$449.17 for the year.
(d) The accumulated balance of the Operating Fund ("working capital") is \$5,808.01,

to begin 2021.

(e) The sum of all funds, including reserves, was \$18,831.07.

INVASIVE SPECIES COMMITTEE REPORT: FEBRUARY 2021 Kent Taylor

It's always a good year for this committee when no invasive aquatic plants are found—and 2020 was another good year. But there is other good news as well.

As you know, Almira Township recently agreed to split the cost with our lake in support for a professional lake management. The township agreed to a new three year contract with PLM, our lake management firm. To make this possible, ALPOA had to ensure we would continue to meet our 50% obligation of \$625 a year (2019-2021). The contract remains in place.

To continue to fund ALPOA's 50% obligation to pay for these services a Lake Preservation Fund was established as an independent fund. It is our vision that this account will be funded each year by the generous donations of our lake residents and eventually, non-members and commercial interests. The ALPOA board is committed to making up the difference each year to meet our obligation to the township. The fund received \$665 in its first year 2019 but only \$50 from non-members. ALPOA did not need to add any money; we rolled over the additional \$40 to give us a head start on 2020. The committee will continue to try to solicit contributions from non-ALPOA members using this vehicle.

Please, bear in mind, this fund is in addition to the Invasive Species Reserve created over the years and sequestered in CD's for use in an actual invasive emergency. That dedicated reserve stands at over \$10,000 and is now closed to new contributions. Instead we ask you to add your contribution to the Lake Preservation Fund when you pay your annual dues to support our annual surveys. We are one of the few lakes in the region not having to deal with expensive plant treatments. Let's try and keep it that way. Thanks to all that contributed over the years to these important contingency funds.

We've lost some members due to attrition and would like more volunteers this year. Please consider joining the group. If interested, contact me at Kent@annlake.org .
