The Loons Have Chicks!

We are elated to report that we have 2 loon chicks! This year the ice was off the lake earlier than usual and it seems that the loons were here earlier than usual. The loons arrived in early April and were looking for the nest.

We launched the nest on April 9th and the loons were checking it out within an hour. But it did take them a little while to “get ready”. They laid their 1st egg on May 1st but didn’t stay on the nest. They started actually staying on the nest on May 2nd so we assume they laid their 2nd egg at that time. The first chick hatched on May 30th and the second chick was on May 31st. We were able to get a picture of the



adult on the nest between hatchings; you can see the chick hiding under its parent. First reports of chicks this year to the MPLA was May 24, so we’re not far behind.

The Association added a Loon sign to the board where the campers check in this spring. With the loon nest located near the camp ground, we noticed that campers who

bring their kayaks are often attracted to the buoys. Since they don’t launch their kayaks at the boat launch, they may not see the sign that is located there.


Treasurer’s Report *by Kathy Garmes Taylor*

The 2020 books were audited in January, 2021. The books were found to be in good order. The 2021 budget was presented at the May Board meeting and approved at the June Board meeting. ALPOA budget is on a cash flow basis. ALPOA targets to have 80 members by the end of each year; this year’s budget is based on 64 paid members since 16 members decided to pre-pay their membership in a prior year. Our expenses remain consistent from year to year. 2020 ended the year with an operating fund of \$5808; this does not include an additional \$13,023 in reserves. To date, we have had a yearly positive cash flow. Our income is \$2710 while our projected expenses are \$2,292.

Invasive Species Committee Report *by Kent Taylor*

Given the outdoor nature of our committee's work, we feel we'll get back to normal quickly this summer. Last year was a troubling and unusual year where having face-to-face meetings was problematic and avoided for this committee. As a result, the committee worked on 'auto-pilot' yet in spite of that, accomplished much of what we do each year. This was a tribute to the inherent commitment, leadership and ingrained competence of our members. Our intent this year is a return to near normal in terms of meetings and joint planning but the desires of the committee has yet to be fully assessed regarding this year's activities but will be reported at the annual meeting. The committee activities we anticipate at minimum this year are as follows:


1. Survey the lake in early June for Curley Leaf Pondweed.
2. Survey the lake in late fall for Starry Stonewort.
3. Survey the shoreline for Purple Loosestrife and arrange for their eradication with as much property owner participation as possible.

Besides this brief list, PLM will be conducting their all-species survey of Lake Ann the first week of August. The Lake Management Fund created to support our share of the PLM expense is again seeing generous support from members. We expect it again this year to fully fund this annual weed management survey. The township continues to subsidize this activity as well. Lake Ann Days has been canceled, as have any committee participation in this event. This is our minimum responsibilities for the year. Other ideas and inspirations are welcome from all members and will be considered and discussed by this committee. We are also looking for new members to serve in this committee. ALPOA ended 2020 with 83 members. As this newsletter goes to print, there are 67 in the fold. Thanks to all of you. Alas, there are a number of you out there who've paid for membership in the recent past but not yet for 2021. I hope you'll use the form included in this newsletter to do so.

And if you haven't been inclined to pay for voluntary membership before, I hope you'll consider it. Our purpose is to promote and protect the interests of all lakefront property owners. For example, our primary focus in recent years has been to carefully monitor and prepare for the presence of invasive Eurasian Watermilfoil. It behooves everyone to share in that concern, because if it gets a foothold, our lake will never be the same.



Water Quality Report *by Dave Maxson*

The statewide data collection and monitoring program, with which ALPOA has participated for years, was suspended for 2020 due to loss of funding. So there is nothing to report for last year. For whatever it's worth, here is a quote from the summary report for 2019, the last year available.

With an average TSI score of 33 (see below) based on 2019 Secchi transparency, chlorophyll-a, and summer total phosphorus data, this lake is rated as an oligotrophic lake. (Deep and clear with little aquatic plant or algae growth.)

The low level of nutrients in the lake results in dissolved oxygen being available throughout the water column for the most of the summer, and only by the end of the summer does the bottom of the lake become anoxic.

Long term trends indicate that the trophic status parameters have not changed beyond minor year-to-year variation since monitoring began.


TSI is a numerical system for evaluating the quality of the water. The lower the score, the better, with the minimum/best being 27. The 2019 average for all lakes in the state was 40.

ALPOA volunteers have resumed efforts to collect samples or record measurements of clarity, phosphorus, chlorophyll, dissolved oxygen, and temperature throughout this 2021 summer season.


Greenbelt of the Year Award

1st prize - Growler of beer (Lake Ann Brewery), \$25 gift card (Stone Oven), \$10 gift card (Corner Cone)


2nd prize - \$25 gift card (Stone Oven), \$5 gift card (Corner Cone)
