# SPRING WATER QUALITY REPORT JONI KESKEY

It's been a cool, wet spring, but water testing begins regardless of Mother Nature. Spring Phosphorus tests were taken in late April and turned in to the DEQ. Water clarity, Chlorophyll and Dissolved Oxygen testing begin on May 15 Th. and will continue weekly (monthly for Chlorophyll) throughout the summer.

Ron Harrison of the Platte River Watershed has applied for a grant to include the upper Platte, including Ann Lake in their extensive testing program. As soon as we hear any more about the grant, we will let you know. For now, enjoy the lake and our animal and fish neighbors. Respect their needs and the needs and rights of your neighbors by obeying the water regulations
